**Karate Program Policy Agreement**

Please read the following agreement carefully. Please keep this for future reference.

1. I understand that there is a 1 day/wk training program, a 2 day/wk training program, and a 3 day/wk program training program, and that each program has different fees. I further understand that there may be times the school is closed on my training days due to holidays, vacation, or other personal or professional business matters of the instructor's. There will be no financial credit for these, as the instructor has factored that into the programs monthly fee.
2. Any person that attends the karate program for one day will be charged for the whole month. I understand there is no prorated fee structure.
3. All karate fees for the month must be paid on time. Your fees are due every 30 days, starting from the beginning or your first payment. For example, if I pay on October 19<sup>th</sup>, I understand my next payment is due on November 19<sup>th</sup> the next month, and late on November 20<sup>th</sup>.
4. Fees are considered late as of closing of that business day.
5. A \$5.00 late fee may be assessed if you are late.
6. Continual late payment (month-after-month) may subject you to dismissal from the Karate program.
7. Fees are to be paid in cash, personal check, or via PayPal (checks must be made payable to Mann's Martial Arts)
8. I understand there will be a \$25.00 fee for the first returned check. The second time we will not accept anymore checks, and all future payments must be made via Paypal, Cash, or Money Order.
9. I understand that pictures of students are occasionally taken and put on the schools website, and that I may or may not be included in them.

**Behavior Policy Statement**

Mann's Martial Arts reserves the right to warn, suspend, or dismiss any program participant/student, based upon the following conditions:

- If their behavior poses a threat to themselves or others
- If they require an inordinate amount of attention for the staff thereby causing inadequate levels of supervision for the remainder of the participants/students.
- If their behavior is determined to be disruptive or inappropriate within the scope, spirit and values of the Karate Program
